- 2. The intending Bidders must have the to submit the quotation rates in the Office of the Assam Olympic Association, R.G. Baruah Sports Complex, D.T.R.P. Indoor Stadium, Ground Floor, Nehru Stadium, Ulubari, Guwahati-781007.
- 3. Period of validity of rates quoted must be mentioned and it should be valid for the financial year (F.Y.), 2024-2025 (i.e. up to 31st March, 2025).
- 4. The bidder should submit Trade licence registered in Assam only.
- 5. The bidder should submit PAN card.
